GENERAL WEED AND GRASS CONTROL

Use WEED-FREE 55-R for post emergence control of certain annual and perennial grasses, weeds and vines such as water-grass, goosegrass, nutgrass cocklebur, and Johnsongrass. Add 1 3/4 to 2 1/2 quarts of product to 40 gallons of water.

DIRECTIONS

The unwanted vegetation should be thoroughly covered with spray to the point of runoff. Spot retreatments may be necessary and should be made where regrowth occurs. Any spray equipment which will give good spray coverage may be used, with power sprayers being particularly effective for such areas as rights-of-way, drainage ditch banks, fence rows, implement storage yards and similar non-crop areas where control of the grasses and weeds mentioned above is desired. Apply when grasses and weeds are growing and preferably before they are 3 inches high. Best results are obtained when the air temperature is 70°F.
