

DIRECTIONS FOR USE

PQ-56 as a concentrate to the detail with water for the control of fungue, hap the mold and termites. This product is higher mended for use where wood is noted, the painted. It is suitable for use on wood that comes in contact with fresh fruits and vegetables, such as fruit baskets regking and storage bins. PQ-56 is an excellent contact for outdoor furniture and terices and a little wooden greenhouse containers.

For above ground use, clute one gallon PQ-56 with 40 gallons of water. A 3-minute dip will give surface protection to the wood in cases where weathering causes checking and splitting; a yearly retreatment program is suggested.

All construction members must be treated prior to installation. If already termite infested wood replacement is absolutely necessary prior to establishing control over reinfestation

For-below ground use, dilute one gallon PQ-56 with 20 gallons of water.

Long term termite and rot control for ground contact applications (such as posts, poles and foundation timber) requires retention of 10 pounds per cubic foot. This can be achieved by pressure treatment or by 12-48 hours soaking in the diluted PQ-56, using only well-seasoned and debarked items.
