

DIRECTIONS

Roaches, Ants, Spiders, Crickets, Ticks, Waterbugs, Millipedes—Spray surfaces where pests appear, travel or enter the premises — around window cracks, crevices and other hiding places. Try to hit insects directly. Look for and spray ant trails. Thorough and repeated applications are recommended in all cases.

Flies, Mosquitoes, Gnats, Wasps — Spray outdoor surfaces of door and window frames, screens, entrances and exit areas, garbage disposal equipment, outdoor lighting fixtures and lighted areas. Repeat as needed to maintain control.

Carpet Beetles and Silverfish — Spray on, under and around the edges of infested areas of carpets, drape hems and piano felts. Spray or paint localized areas of floors, baseboards and closet shelves, giving particular attention to cracks. Thorough and repeated applications are recommended as often as necessary to maintain effective control.

Clothes Moths in clothing, blankets and other woolens—Thoroughly dampen all surfaces with insecticide and allow to dry before placing in storage. Dry clean all treated articles before use as bedding or clothing. Spray closet walls, ceiling, and floor. Also thoroughly spray the interior surfaces of trunks and other storage containers, in order that all moth larvae feeding on lint in the cracks be killed. Repeat monthly unless the treated articles are stored in mothtight containers.






