The proposed label revision referred to above, submitted in connection with registration under the amended Federal Insecticide, Fungicide and Rodenticide Act is acceptable with comments. Our comments are as follows:

Revise "As solution becomes dirty, discard and replace with a fresh one.", to read as follows: Daily discard solution or when it becomes dirty and replace with a fresh one.

If any revision was made to the subject product label to alter it from the approved label, dated February 20, 1997, other than in the "Directions For Use" section, as specified in the amendment submission dated July 22, 1997, the product registration will become subject to cancellation in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act section 6(e).

PRECAUTIONARY STATEMENTS

HAZARD TO HUMANS AND DOMESTIC ANIMALS: Contosive; Causes eye and skin damage, Do not get in eyes, on skin or on clothing. Wear goodes or face shield and number gloves when handling. Harmful if swallowed.

STATEMENT OF PRACTICAL TREATMENT: In case of eye contact, immediately flush eyes with water for 15 minutes and get prompt medical attention. For skin contact, flush thoroughly with water. Remove and wash contaminated clothing before reuse. If swallowed promptly drink a large quantity water. Avoid alcohol, Do not induce vomiting, Call physician immediately. NOTE TO PHYSICIAN: Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsion may be needed.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. CLEANING AND DISINFECTING WASHABLE, HARD, NON-FORUS SURFACES: Add 1 fl. oz. (30 cc) to each measured gallon of water used. Always add thus product to premeasured water. Thoroughly mix solution until uniform. Apply solution with a cloth, sponge, mop or brush using normal cleaning methods. Allow treated surfaces to soak for 10 minutes. Then remove exerss solution with a wrung-out applicator. Remove gross filth mechanically by sweeping before cleaning begins. As solution becomes dirty, discard and replace with a fresh one. This is a complete product. Do not add other chemicals. If frozen, thew and remix. Use only as directed.

CLEANING AND DISINFECTING WASHABLE, HARD, NON-PORUS SURFACES: To make a one gallon (1:128) solution, loosen cap from dispensing chamber. Gently squeeze bottle to fill measuring chamber to the I fluid ounce line (30 cc.). Remove cap from the dispensing chamber. Pour measured product (concentrate) from the chamber into one gallon premeasured cold water. Apply solution with a cloth, sponge, mop, brush or from spray bottle using normal cleaning methods. Treated surfaces should remain wet for 10 minutes. Then remove excess solution with a wrung-out applicator. Remove gross fith mechanically by sweeping before cleaning begins. Discard solution daily or when it becomes dirty and replace with a fresh solution. This is a complete product. Do not add other chemicals. If frozen, thaw and remix. Use only as directed.

It is effective in hard water and in the presence of serum. It has been formulated as a concentrate to clean, disinfect and deodorize simultaneously. Use this product for easy cleaning and disinfecting of all washable hard, non-nonus environmental surfaces such as floors, walls, woodwork, bathroom fixtures, equipment and furniture. It may be used for cleaning and disinfecting chrome, stainless steel, other metal surfaces, porcelain, glass, tile, washable painted or varnished surfaces, as well as resilient vinyl, asphalt, linoleum, terrazzo or other combination type floors. This product is not for use in the neonated (newborn) units in hospitals, specifically isolates and other infant contact surfaces. This germicidal detergent is intended for use in institutions such as hospitals and nursing homes, industrial plants, schools, medical and dental offices, pharmaceutical plants, veterinary clinics and other indoor areas where disinfection, cleaning and deodorizing are a necessity.

This product is not to be used as a terminal sterilant/high level disinfectant on any surface or instrument that (1) is introduced directly into the human body, either into or incontact with the bloodstream or normally sterile areas of the body, or (2) contacts intact mucous membranes but which does not ordinarily penetrate the blood barrier or otherwise enter normally sterile areas of the hody.

GERMICIDAL: Passes A.O.A.C. Germicidal Use-Dilution Method (S. aureus, S. choleraesuis, Ps. aeruginosa) when diluted with 400 ppm A.O.A.C. hard water to make a 1:128 (I ounce per I gallon) solution, in the presence of 5% organic soil (serum), 10 minutes at 20°C.

Vesphene II se is effective in 3 minutes at 20°C against Pseudomonas aeruginosa ATCC 13388, according to the A.O.A.C. Use Dilution Test when diluted with 400 ppm hard water to make a 1:64 (2 ounces per gallon) solution, in the presence of 5% added organic soil (serum).

FUNGICIDAL: Passes A.O.A.C. Fungicidal Test (T. mentagrophytes) when diluted with 400 ppm A.O.A.C. hard water to make a 1:128 (1 ounce per I gallon) solution, in the presence of 5% organic soil (serum), 10 minutes at 20°C.

TUBERCULOCIDAL: Passes A.O.A.C. Tuberculocidal Test (Mycobacterium tuberculosis. var. bovis) when diluted with 400 ppm A.O.A.C. hard water to make a 1:128 (1 ounce per 1 gallon) solution, in the presence of 5% organic soil (serum), 10 minutes at 20°C.

*VIRUCIDAL: Passes Virucidal Assay (EPA Proposed Method) [Influenza A, (Japan). Herpes Simplex Type 2, Vaccinia Virus, and Adenovirus Type 2, Avian Infectious Bronchitis, Avian Laryngotracheitis, Avian Newcastle Disease, and Porcine Pseudorabies], when diluted with 400 ppm A.O.A.C. hard water to make a 1:128 (1 ounce per 1 gallon) solution in the presence of 5% organic soil (serum) in 10 minutes at 20°C.

When tested by an EPA-approved Dilution Method, the HIV-1(AIDS) virus, with added 10% organic soil (serum), was completely inactivated by a 1:128 (1 ounce per 1 gallon) solution in 400 ppm A.O.A.C. hard water in 60 seconds at 20-25°C. Although efficacy at I minute contact time has been shown to be adequate against HIV-1, this time would not be sufficient for other organisms. Use a 10-minute contact time for disinfection against all of the organisms.

ODOR CONTROL: It climinates many odors by killing odor-causing bacteris while simultaneously chemically neutralizing their odors and leaving a pleasant fragrance.
