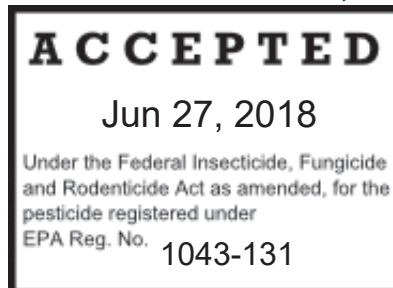

Remove any obvious debris or organic material from the surface to be disinfected. This can often be accomplished by rinsing with purified water (e.g. deionized), mechanical action, or by detergent cleaning followed by a water rinse. Roll outer pouch to release liquid onto the wipe material. Peel back the label. Remove wetted wipes from pouch. Use as many wipes as needed to thoroughly wet surfaces for 10 minutes. Wear gloves when handling wipes. After use, discard pouch and any unused wipes.

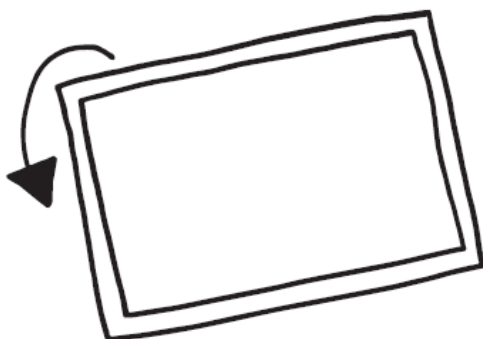
Spor-Klenz Ready-To-Use Disinfectant Wipes require saturation of the dry wipes contained in the package at point of use.

Preparation of wipes:

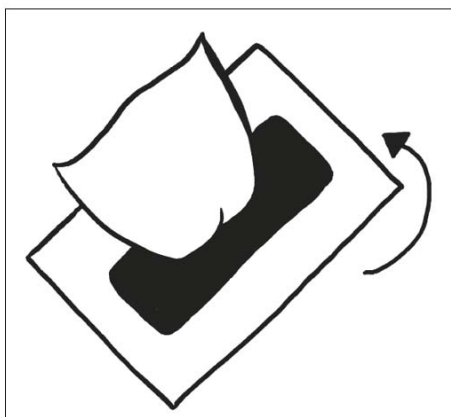
1. Ensure package opening is facing up. Use two hands to roll one end of the pouch and apply pressure until you feel the inner packet containing the Spor-Klenz Ready-To-Use Disinfectant Wipes release the disinfectant solution.



2. Invert pouch until wipes are fully saturated.



3. Using the resealable cover, remove wipes. Reseal once desired number of wipes have been removed.



Product that has been saturated must be discarded daily.

DO NOT USE AFTER EXPIRATION DATE. Do not allow SPOR-KLENZ Ready-To-Use Disinfectant Wipes to mix with alkaline substances such as bleach (Sodium Hypochlorite) or other oxidizing agents.
