Septihol® Ethyl WFI st Alcohol Solution is effective in the presence of organic soil (5% blood serum) on hard, non-porous surfaces and may be used for easy cleaning and disinfecting of all washable hard, non-porous environmental surfaces such as floors, walls, woodwork, bathroom fixtures, equipment and furniture. It may be used for cleaning and disinfecting chrome, stainless steel, glazed porcelain, glass, tile, non-porous washable painted or varnished surfaces, as well as resilient vinyl, linoleum, sealed terrazzo or other combination type floors.

DISINFECTANT: This product was tested using the A.O.A.C. Germicidal Use-Dilution Test against *Staphylococcus* aureus (ATCC 6538) and *Pseudomonas aeruginosa* (ATCC 15442) and it passed in the presence of 5% organic soil (serum), 10 minutes at 20°C.

FUNGICIDAL: This product was tested using the A.O.A.C Fungicidal Test against *Trichophyton interdigitale* (ATCC 9533) and it passed in the presence of 5% organic soil (serum) in 5 minutes at 20°C

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. This product is not for use on medical device surfaces.

CLEANING AND DISINFECTING WASHABLE, HARD, NON-POROUS SURFACES: Before cleaning begins, always sweep or dust mop area to be cleaned thoroughly, removing any gross filth. Apply solution with a cloth, sponge, mop, brush or by coarse spray using normal cleaning methods. Allow treated surfaces to remain wet for 10 minutes, then remove excess solution with a wrung-out applicator. This is a complete, ready-to-use product. Do not add or dilute with other chemicals. Use only as directed.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

PESTICIDE STORAGE: Do not store near heat or open flame. If frozen, thaw and re-mix before use.

Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times.
