COMPACTOR & KITCHEN PYRETHRUM INSECTICIDE

DIRECTIONS

VIII A
 For rapid control of roaches, ants, spiders, crickets, silverfish and centipedes. Aids in the control of exposed stages of cheese mites, meal worms, grain beetles (confused flour beetles, red flour beetles) and weevils (granary weevils, rice weevils). Apply in a good sprayer adjusted to deliver a coarse wet spray, at a rate of 1 gallon to 750 square feet of surface. Direct spray into locations where these insects are found; garbage compactors, garbage chutes and cans, into cracks and crevices, dark corners, behind and beneath sinks, stoves, refrigerators, and cabinets, along baseboards, and around door and window frames. Spray ant trails, nests and points of entry. Spray insects directly wherever possible.

VIII B
 In case of infested foods in cabinets, dispose of the infested material. Remove all contents and clean thoroughly. Spray interior surfaces of empty cabinets thoroughly. After spray has dried, cover shelves with paper or otherwise protect foods from direct contact with sprayed surfaces.

Repeat treatment if reinfestation occurs.

VIII A
 To kill flies, fruit flies, mosquitoes, gnats, flying moths, wasps and hornets: Close windows and doors and shut off ventilating systems. Remove pets, birds and cover fish aquaria before spraying. Apply as a fine mist using a non-thermal sprayer. Thoroughly fill the area with mist with special attention to light sources which attract these insects. Keep area closed for 15 minutes. Vacate treated area and ventilate before reoccupying.

CAUTION: Harmful if swallowed. Foods should be removed or covered during treatment. All food processing surfaces should be covered during treatment or thoroughly cleaned before using. When using the product in these areas, apply only when the facility is not in operation. Do not apply as a space spray while food is being prepared.

This product may be toxic to fish. Do not contaminate water by cleaning of equipment or disposal of wastes. Apply only as specified on this label.

Do not reuse this container. Destroy by perforating or crushing and burying in a safe place.
