DIRECTIONS FOR USE

Hanoeight is a contact herbicide useful for killing annual weeds and tops of perennial plants especially around mills, elevators, tumber yards, tank farms and pipe line in-stallations. Usually good control of perennial plants is obtained by spot treatment of regrowth.

Where minimum fire hazards or residual toxicity is desired. Hanoeight should be diluted with water. Hanoeight diluted with oil, especially heavier oils, will give good residual control of annuals and better control of perennials.

For use as a water emulsifiable produc Ш where minimum fire hazard is desired, dilut one gallon of Hanoeight with 4 to 7 gallon of water. Apply this spray to thorough C cover all weeds (from 200 to 400 gallons pe acre).

Spot treat any regrowth of undesirab vegetation.

For use with oils, dilute one gallon of Hanoeight with 10 to 15 gallons of diesel fuel, fuel oil, crank case drainings, or other oil and apply as a spray to thoroughly wet weeds (about 100 to 300 gallons per acre). Spot treat all regrowth.


