DANGER

Concentrated solutions are corrosive and cause severe eye and skin damage. Do not get in eyes, on skin or on clothing. MAY BE FATAL OR HARMFUL IF SWALLOWED.

STATEMENT OF PRACTICAL TREATMENT

IF ON SKIN: Immediately remove contaminated clothing. Wash affected areas with soap and water. Wash contaminated clothing before reuse.

IF IN EYES: Flush with water for at least 15 minutes and get medical attention.

NOTE TO PHYSICIAN: Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsion may be needed.
