**Important Note to Formulators**

- **IGR 10.5 Base Mix** is a light, fluffy product and therefore, whenever possible, add the material directly to the mixer. Avoid elevators, long free-fall gravity chutes, etc.
- It is critical, in order to avoid loss of the low density premix, that additions are made under conditions of low air turbulence or flow (shut off exhaust systems during IGR Cattle Premix addition).
- Whenever possible, add the **IGR 10.5 Base Mix** after the addition of the liquid components and blend to homogeneity.

<p><b>STORAGE AND DISPOSAL:</b> Protect from heat. Do not contaminate water or feed by storage or disposal. Store in a cool, dry area. Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. Triple rinse (or equivalent) containers. Then offer for recycling, reconditioning, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state or local authorities.</p>
