For a preventive disease control program (4 lbs. per 1000 sq. ft.) set spreader at the regular rate indicated on this bag. For eradicative spot treatment of severely diseased areas, set spreader for 1½ re. (6 lbs. per 1000 sq. ft.)

For best results, the lawn should be moist when making application. Just after a light shower or in the morning when dew is on the grass is ideal. TURF FUNGICIDE should not be applied when rain is expected within 24 hours. DO NOT WATER OR MOW FOR AT LEAST 24 HOURS AFTER APPLICATION.

FOR CONTROL OF HELMINTHOSPORIUM LEAF SPOT, MELTING OUT and CURVULARIA, START application at PREVENTATIVE RATE in early spring and continue at 7-10 day intervals as long as wet weather prevails.
