

**COOLING TOWERS:** TR-1170  
wood against soft or surface rot and internal or dry rot. Application containing 0.5 to 0.7% by weight TR-1170 on wood surfaces. The amount applied should provide 0.6 lb. per 1000 ft.<sup>2</sup> of wood surface. Soft or surface rot can be controlled by TR-1170 to the

cold well. The dosage should provide 1.25 lb. of TR-1170 per 1000 gal. of water, and the bleedoff should be stopped. Treatment should be repeated every four months.

**COOLING WATER:** TR-1170
