DIRECTIONS FOR USE

FOGGING

Midland Vapona Insecticide Stock Spray is recommended for use in stationary and electric barn foggers. Kills face flies, house flies, stable flies and gnats at time of spraying. Fog at the rate of 2 ounces per 1,000 cubic feet.

DO NOT use in areas containing animals which have received direct application of Vapona Insecticide within 8 hours. For best results treated area should be closed for 10 minutes.

DIRECTED SPRAY

KILLS STABLE FLIES, HOUSE FLIES, HORN FLIES, FACE FLIES AND MOSQUITOES. Apply Midland Vapona Insecticide Stock Spray at the rate of 2 ounces per animal to dairy cattle, beef cattle and horses. For maximum results apply in 2 applications—1 ounce in the morning and 1 ounce in the evening. DO NOT APPLY MORE THAN 2 OUNCES PER ANIMAL PER DAY. Use a reduced application rate for calves. Apply a fine mist permitting the spray particles to collect upon the hair of the animal. Give special attention to shoulders, belly and legs. Wash teats and udder with an approved cleansing solution prior to milking.
