DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

IN NON-RESIDENTIAL FOOD-HANDLING AREAS OF: Food processing plants, schools, taverns, grocery stores, hotels, motels, bottling plants, canneries, bakeries, cafeterias, hospitals and restaurants. Remove protective cap. Holding dispenser upright, point valve in desired direction and press dispenser button to spray

MOSQUITOES, FLIES, GNATS, SMALL FLYING MOTHS: Close all doors and windows. Direct the spray to all parts of the room. Fill the room with mist, then leave the treated area. Keep room closed for at least 15-30 minutes. Do not remain in treated area. Ventilate the area after treatment is completed. Sweep up and destroy fallen insects. Repeat treatment as necessary.

WASPS: Application should be made in late evening when insects are at rest. Spray liberally into hiding and breeding places, contacting as many insects as possible. Repeat as necessary.

STORAGE AND DISPOSAL

Storage: Do not use or store near heat or open flame.
 Disposal: Do not reuse empty container. Wrap container and put in trash collection.
