Directions for Use

GENERAL CLASSIFICATION

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

This product is a proven "one-step" cleaner-disinfectant-sanitizer-fungicide-mildewstat-virucide in the presence of moderate amounts of organic soil.

Apply **THIS FORMULATION** to walls, floors and other hard (inanimate) non-porous surfaces such as tables, chairs, countertops, tile, porcelain, sinks and bedframes with a cloth, mop or mechanical spray device so as to thoroughly wet surfaces. For heavily soiled areas, a preliminary cleaning is required. Prepare a fresh solution daily or when use solution becomes visibly dirty.

Disinfection - to disinfect hard non-porous surfaces, add 1 oz per gallon of water. Treated surfaces must remain wet for 10 minutes. Mold and Mildew Control
