

MIXING DIRECTIONS

Mix Toxaphene Emulsifiable with water by agitation or by circulating the mixture through the spray pump and back into the tank. A proper mixture will have the appearance of a milky emulsion with no free oil on the surface. Agitate the mixture while spraying. IF MIXTURES ARE ALLOWED TO STAND, RE-AGITATE them before using, until a uniform emulsion is formed.

This product may be applied either by aircraft or ground equipment. If applied by air dilute with water to give approximately 3 to 10 gallons of diluted spray per acre, consistent with crop growth and good coverage. If applied by ground equipment mix with whatever amount of water your spray rig delivers effectively — however it is suggested that a minimum of 6 gallons of diluted spray per acre be used.
