For hornworms, budworms, aphids, flea beetles, suckfly, grasshoppers and Japanese beetle, apply 20 to 40 pounds per acre depending on the size of the plants. Make applications when insects first appear and repeat as necessary. Avoid excessive applications.

For budworms, when dust applications are directed to the bud and top leaves only, apply 6 to 8 pounds per acre. Wear natural rubber gloves protective clothing and gongles. Wear in mask or restrictor is a time of the U.S. Dept. of Agriculture for Parathion protection while performing these operations. Do not apply with cloth bags.

Do not apply within five days of priming or fifteen days of cutting. Avoid getting wet with plant juices when cutting the crop.
