Do not exceed rates given.

Do not apply after days indicated.

COTTON: Apply I/2-2 I/2 pints per acre to control thrips, flea hoppers. Apply I-2 I/2 pints per acre to control boll weevils, cotton bollworms, cabbage looper, brown cotton leafworm, leaf perforator, cotton leafworm, lygus bugs, tarnished plant bug, saltmarsh caterpillar, cutworms, fall armyworms, garden webworm, grasshopper. Do not graze livestock on treated fields. Workers entering fields within 5 days after treatment should be protected. Do not apply within 5 days of hand picking.

SMALL GRAINS (Barley, Oats, Rye, Wheat): Apply 1-11/4 pint per acre to control armyworms, army cutworms, pale western cutworms, chinch bugs, cutworms, fall armyworms. For single application. Do not apply within 45 days of harvest. Do not graze livestock on treated forage. Do not feed threshings to livestock.

FLOWERS (Asters, Daisies, Gladiolus, Mums, Iris, Stock): Apply 1-3 pints per acre to control thrips, cutworms, armyworms, corn earworms. Caution — may cause injury to some varieties.




