



TERRACHLOR 10 GRANULES

ACTIVE INGREDIENT:
 Pentachloronitrobenzene 10%
 INERT INGREDIENTS 90%

DIRECTIONS

BEANS: Furrow treatment - Apply 15-24 lbs. per 8400 linear feet of row for pole beans or ~~14,500 linear feet~~ for bush beans to control root and stem rots (rhizoctonia). Distribute over the seed and surrounding soil as the beans are planted.

COTTON: Row treatment - Apply 10-20 lbs. per 12,400 linear feet of row to control rhizoctonia induced damping-off, seedling blight, seedling rot, sore-shin. Apply in furrow over seed and surrounding soil at planting time. If a seed-embedding wheel (seed press wheel) is used, the granules may be simultaneously applied, through the seed drop tube and the mixing device attached at the end of the granule delivery tube. This can be done by dividing the granule flow through a "Y" connection. Use the lower application rates for light soils and heavy application rates for heavy clay soil. Do not allow the feeding or grazing of cotton foliage by livestock. Do not plant any root crop not registered for PCNB in rotation on PCNB treated soil.
