

DIRECTIONS FOR USE

For aircraft or ground rig application. Apply recommended rates when disease appears and repeat at 7-10 day intervals as long as necessary.

FRUIT AND NUT CROPS

ALMONDS (California): Apply 30-130 lbs. per acre to control shot hole, brown rot. Do not apply later than 5 weeks after petal fall. Do not feed almond hulls to dairy animals or animals being finished for slaughter.

APRICOTS (California): Apply 40-150 lbs. per acre to control brown rot, shot hole. Do not apply within 14 days of harvest.

NECTARINES, PEACHES (California): Apply 40-100 lbs. per acre to control shot hole, peach leaf curl, fruit brown rot. Do not apply within 14 days of harvest. Remove residue by brushing.

VEGETABLE, FIELD AND FORAGE CROPS

BEANS (Dry): Apply 20-55 lbs. per acre to control downy mildew, rust. No time limitation.

BEANS (Succulent): Use recommended rates and diseases controlled under beans (dry). Do not apply within 4 days of harvest.

BROCCOLI, BRUSSEL SPROUTS, CABBAGE, CAULIFLOWER, KOHLRABI: Apply 25-30 lbs. per acre to control downy mildew, alternaris leaf spot. Do not apply within 7 days of harvest of cabbage, broccoli.

CELERY: Apply 25-50 lbs. per acre to control early and late blight. Remove excess residues by stripping, trimming, and washing.

CUCUMBERS, SQUASH, MELONS, PUMPKINS: Apply 25-40 lbs. per acre to control downy mildew, anthracnose, gummy stem blight.

EGGPLANTS, PEPPERS: Apply 25-40 lbs. per acre to control fruit rot, anthracnose.

LETTUCE: Apply 25-40 lbs. per acre to control downy mildew. Do not apply within 7 days of harvest. Remove residues from head lettuce by stripping and trimming, and from leaf lettuce by washing or other effective means.

POTATOES: Apply 25-50 lbs. per acre to control early and late blight.

SPINACH: Apply 25-45 lbs. per acre to control downy mildew, white rust. Do not apply within 7 days of harvest. Remove excess residue by washing.

TOMATOES: Apply 25-70 lbs. per acre to control early and late blight, anthracnose, stemphylium, septora leaf spot, cladosporium grey mold.

FLOWERS (Asters, Iris, Mums, Gladiolus): Apply 25-40 lbs. per acre to control stemphylium, curvularia, botrytis.
