

## DIRECTIONS FOR USE

For aircraft or ground rig use.

**PEPPERS** (Dry, Lima, Green): Apply 50 lbs. per acre to control mites, aphid, lygus bug. Do not apply within 7 days of harvest. Do not feed treated vines to dairy or meat animals.

**COTTON:** Apply 35 lbs. per acre to control armyworms, fleahopper, lygus bugs. Do not apply within 14 days of harvest. Do not graze treated fields by meat or dairy animals.

**EGGPLANTS:** Apply 40 lbs. per acre to control mites, aphids. Do not apply within 4 days of harvest.

**GRAPES:** Apply 40-50 lbs. per acre to control leafhoppers, mites. Do not apply within 7 days of harvest.

**PEPPERS:** Apply 25 lbs. per acre to control aphids, flea beetle, leaf miner, mites. Do not apply within 4 days of harvest.

**STRAWBERRIES:** Apply 40-50 lbs. per acre to control aphids, mites. Do not apply within 4 days of harvest.

**TOMATOES:** Apply 25 lbs. per acre to control tomato fruitworm, hornworm, leafminer, fruit fly. Do not apply within 4 days of harvest.

**FLOWERS** (Stock, Asters, Iris, Mums, Daisies, Gladiolus): Apply 40-50 lbs. per acre to control aphid, mites.
