**DIRECTIONS FOR USE**

Under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, this pesticide registered under EPA Reg. No. 1202-289

*With comments*

**TOMATOES:** Apply 20 lbs. per acre to control drosophila, two-spotted mite, aphids, leafminer. Do not apply within 4 days of harvest.

**BEANS:** Lygus Bugs, Stink Bugs, Mexican Bean Beetle — 20 lbs. per acre. Apply thoroughly when insects appear and repeat every 7 to 10 days as necessary. Do not apply within 4 days of harvest.

**COTTON:** Salt-Marsh Caterpillar, Bollworms, Lygus Bug, Cotton Leaf Perforator — 17 lbs. per acre. Apply as insects appear. Repeat at 7- to 10-day intervals while pests persist. Do not apply within 4 days of handpicking.

**GRAPES:** Grape Leafhopper, Red-banded Leafroller — 17 lbs. per acre. Apply thoroughly when insects appear and repeat as necessary. Do not apply within 4 days of harvest.

**PEACHES:** Mites, Oriental Fruit Moth, Peach Twig Borer — 30 lbs. per acre. Do not apply within 4 days of harvest.
