DIRECTIONS

For best results, use in a good sprayer or atomizer adjusted to deliver a fine mist. Treat infested areas, thoroughly and repeat application as needed. Whenever possible, keep windows and doors closed for 10 mic ates after spraying.

in the control of flying insects, direct the spray toward the upper portions of the enclosure, and fill the atmosphere with mist, using two to three ounces to each 1,000 cubic feet of space.
