**APPLICATION INFORMATION**

Select the proper dilution of Foremost 4520 Pine Oil Disinfectant for your use from the directions below. Apply the use solution with a clean mop, sponge, cloth, squeegee or mechanical scrubber.

Prepare fresh use solutions daily. Do not reuse solution. Discard solutions when they become visibly soiled. For disinfection, thoroughly wet the surface to be treated. Surfaces must remain moist for at least 10 minutes to assume proper germicidal action.

This product may be used for cleaning and disinfecting hard, non-porous, inanimate environmental surfaces (glass, metal, glazed porcelain, linoleum, tile, smooth leather vinyl, enameled and finished wood surfaces) on walls, floors, appliances and furnishing.

**CLEANING**

**TO CLEAN AND DEODORIZE OR TO PRECLEAN PRIOR TO DISINFECTION:** Depending on the soil level of the area to be cleaned, use 2 to 6 oz. of Foremost 4520 Pine Oil Disinfectant per gallon of water.
