Amendment To Previously Registered Labeling

Add the following:

LAWNS AND TURF

Spring dead spot complex of Bermuda grass: Apply at the rate of 10 lbs. per 1,000 sq. ft. Applications should be made in spring or fall of each year for suppression of existing infections. Following application, the treated area should be lightly watered to insure movement of the chemical to the soil level.

Seedling damping off and soil and root disease complex caused by Rhizoctonia, Fusarium, Pythium and Helminthosporium: Apply at the rate of 10 lbs. per 1,000 sq. ft. Applications to growing turf should be made in the fall or spring at the first indication of infection. Water area lightly to wash chemical down to soil level. Application to newly seeded areas should be made just prior to seeding. For best results, mix granules in the top 1 to 2 inches of soil. If any treated area is subject to unusually heavy rainfall, or flooded, or if the disease is severe or reappears, the area should be retreated 3 to 4 weeks later.

<u>NOTE</u>: Under certain growing conditions, a temporary discoloration of turf grasses occasionally may occur. This condition causes no harm, and with proper watering and fertilization will disappear in a short time.

Do not graze treated areas or feed clippings to livestock.
