

GENERAL DIRECTIONS

ATOES: For the control of Japanese Beetle larvae, Whiteed Beetle larvae, White Grubs and Wireworms.

ADCAST APPLICATION: Spread 1200 to 1500 pounds ily over the soil surface just prior to planting and work evenly the top 3 to 6 inches of soil.

NTREATMENT: At planting time apply 400 to 500 pounds acre in a band and work into the soil to give uniform coverage e principal root growth area.

E: Recommendations may vary from place to place, depending upon soil types. For more specific information concerning your area consult your State agricultural experiment station.
