DIRECTIONS FOR USE ON PEANUTS

For the control of Southern blight (Southern Stem and Root Rot)-Sclerotium rolfsii; Aphids, Leafhoppers, Mites and Thrips:

ROW (IN-FURROW) TREATMENT: Apply 100 lbs. per acre (1 lbs. to 124 linear feet of row) in an 8 to 12 inch band centered on the row and mixed with the soil to a depth of 2 to 4 inches. Application may be made simultaneously with planting, using suitable application equipment. Avoid application techniques which will allow direct contact of the granules with the seed.

SURFACE BAND TREATMENT: This product may be applied at pegging time, as a side-dressing, using 100 lbs. per acre (1 lb to 124 linear feet of row).

NOTE: Do not feed treated vines to livestock. Do not allow hogging down of treated peanuts.

Do not plant any root crop not registered for PCNB in rotation on PCNB[®] treated soil.
