#### **SOYBEAN PLANTER BOX TREATMENT:**

Terraclor Super-X-- with Graphite is formulated for planter box treatment of soybeans to control seedling disease complex (Pythium, Thielaviopsis, Rhizoctonia and Fusarium).

Mix 4 to 8 ozs. per bushel of seed and apply through planter box at planting time, at the rate of approximately one bushel per acre.

Note: A non-oil lubricant has also been added to help seeds flow more easily and evenly from the planter box.
