GENERAL DIRECTIONS FOR FORMULATING

OCI-56 is to be used only for repackaging or formulating as a disinfectant, senitizer, fungicide, bactericide, and algaecide. OCI-56 may be thoroughly-mixed with sodium bicarbonate to obtain a formulated product. Before the new product can be lawfully distributed in interstate commerce, registration by the Engironmental Protection Agency is required.

STORAGE AND DISPOSAL:

Keep product dry in tightly closed container when not in use. Store in a cool, dry, wellventilated area where the temperature never reaches 140° F or higher for any length of time.
