

For bedding and bench plantings use with water, as a soil drench at time of seeding and transplanting. The drench solution should be continually agitated to assure uniform application of the fungicidal material. To improve penetration of the fungicide, the drenching should be followed with an equal quantity of water, applied either by sprinkling or by irrigation.

Alyssum, nthemum, anthus, etunia, Vinca,	BEDDING PLANTS: (Soil 2" to 3" deep):- Add 3/4 to 1 oz. to 25 gallons of water and apply to 100 sq. ft. of bed area. Repeat application may be made at one to two month intervals, if necessary.
laonema, vergreen, hthytis, Pothos,	in 25 gallons of water and apply to 100 sq. ft. of bed or bench area. Repeat application at two to three month intervals to maintain
