For inhibition of sulfate reducing bacteria for up to 36 weeks in clean (free of slime and sludge) seawater displacement tanks used for the storage of liquid hydrocarbons. Dissolve 1 lb. of OMADINE TBAO in 5 gallons of water and feed directly to the incoming seawater ballast at the rate of 1 gallon per 600 gallons seawater. Repeat dosage as needed or whenever the storage tank is drained and refilled. Before draining the treated seawater from the tank, treat with calcium hypochlorite (65% active) at the rate of 50 ounces (avdp) per 3,000 gallons water. Wait 24 hours before discharging the seawater. This procedure will restroy the preservative.

STORAGE AND DISPOSAL
