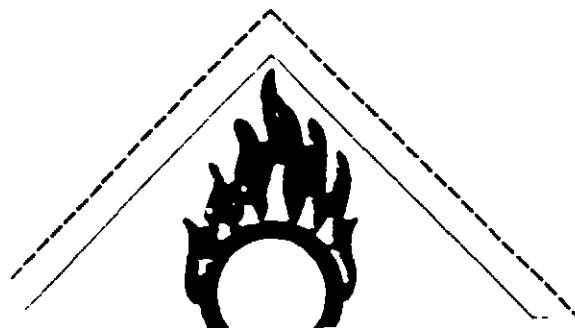

PRECAUTIONARY STATEMENTS:
HAZARDS TO HUMANS AND DOMESTIC ANIMALS**DANGER:**

Highly corrosive. Causes skin and eye damage. May be fatal if swallowed. Do not get eyes, on skin or on clothing. Do not handle with bare hands. Wear goggles or face shield, use rubber gloves, and use only thoroughly clean, dry utensils when handling irritating to nose and throat. Avoid breathing dust and fumes. Remove and wash contaminated clothing before reuse.

CHEMICAL HAZARDS**DANGER:**

Strong oxidizing agent. Use only clean, dry utensils. Contamination with moisture, dirt, organic matter or other chemicals (including pool chemicals) or any other foreign matter may start a chemical reaction with generation of heat, liberation of hazardous gases, possible generation of fire or explosion. Avoid any contact with flaming or burning material such as a lighted cigarette. This product decomposes at 430° - 480° with liberation of heat and harmful gases. Do not use this product in any chlorinating device which has been used with any inorganic or unstabilized chlorinating compounds (e.g., calcium hypochlorite). Such use may cause fire or explosion.

ENVIRONMENTAL HAZARDS:

This product is toxic to fish. Do not discharge into lakes, streams, ponds, oceans, or public waters unless specifically identified and addressed in an NPDES permit.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its label. This product is to be used only for repackaging or formulation as a disinfectant, sanitizer, fungicide, bactericide, and algicide. Repackagers or reformulators must obtain their own registrations to legally market their product for these uses.

STORAGE AND DISPOSAL:

Keep product dry in tightly closed container when not in use. Store in a cool, dry, well-ventilated area away from heat and open flame. Do not contaminate water, food or feed by storage or disposal. Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal Law. If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste representative at the nearest EPA Regional Office for guidance. Do not reuse empty container. Completely empty by shaking and tapping sides and bottom to loosen clinging particles. Empty residue application equipment. Then dispose of liner in a sanitary landfill or by incineration if allowed by State and local authorities. Dispose of drum in the same manner.

EMERGENCY HANDLING: In case of contamination or decomposition of product, not reuse container. If possible, isolate container in open and well-ventilated area. Flush with large volumes of water. Dispose of contaminated material in an approved landfill area.
