DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Controls Rhizoctonia, Pythium and Fusarium seed and soil-borne seedling diseases of cotton and rice. Using suitable liquid or slurry seed treating equipment such as Panogen or Mist-O-Matic, apply Terra-Flo 25 at rates shown below. Seed should be sound, well cured and cleaned prior to treatment. Use only the recommended rates per 100 pounds of seed.

COTTONSEED:

Acid delinted 13 fl. ounces (400cc)

Mechanically delinted 18 fl. ounces (533cc)

RICE:

4 to 9 fl. ounces (133 to 266cc)

At the recommended rates, apply Terra-Flo 25 undiluted directly from the drum to the seed. If desired, add one part water to five parts Terra-Flo 25 and recalibrate equipment so that recommended rates will still be applied. Slight agitation may be required to mix the material. Keep container tightly closed when not in use. Do not feed treated seed to animals.

STORAGE AND DISPOSAL

Prohibitions: Do not contaminate water, food, or feed by storage or disposal.

Container Disposal: Rinse containers and dispose of in an incinerator or landfill approved for pesticide containers.

General: Consult Federal, State or local disposal authorities for approved alternative procedures such as limited open burning.
