DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. OLIN HTH ALL PURP ALGICIDE-30 EXTRA STRENGTH is used to control the growth of algae

in swimming pools, exterior spas, whirlpools, hot tubs, decorative fountains, and ponds that do not contain fish. For maximum effectiveness pools, spas, whirlpools, hot tubs, decorative fountains, and ponds containing heavy growth of algae should be cleaned prior to using OLIN HTH ALL PURPOSE ALGICIDE-30 EXTRA STRENGTH

For pools having just visible algae growth add an initial dose of 24 to 36 fluid ounces of OLIN HTH ALL PURP ALG-30 per 10,000 gallons of water and remove settled algae debris by cleaning. For treatment of a freshly cleaned and filled pool add initially 13 to 24 fluid ounces of OLIN HTH ALL PURP ALGI-30 per 10,000 gallons of water. Subsequent additions of 4 to 9 fluid ounces of OLIN HTH ALL PURP ALG-30 per 10,000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, decorative fountains, and ponds having just visible algae growth require an initial dose of 2 to 4 fluid ounces of OLIN HTH ALL PURP ALG-30 per 1,000 gallons of water. For treatment of a freshly cleaned spa, whirlpool, hot tub, decorative fountain, or pond, add initially 1 to 2 fluid ounces of OLIN HTH ALL PURP ALG-30 per 1,000 gallons of water. Subsequent additions of 0.5 to 0.8 fluid ounces of OLIN HTH ALL PURP ALG 30 should be made every 5 to 7 days after initial treatment for maintenance.

OLIN HTH ALL PURPOSE ALGICIDE-30 EXTRA STRENGTH

will prevent growth of most algae during the off-season winter months when pools are not in use. For pools which have been properly treated during the swimming season and are free of visible algae, add 13 to 21 fluid ounces of algicide per 10,000 gallons of water. If at the end of swimming season pools have some visible algae growth, add 25 to 37 fluid ounces per 10,000 gallons. It is necessary that a uniform distribution of algicide throughout the water and the pool be made for maximum effectiveness. If pool is not covered, it may be necessary to repeat the treatment one or more times during the season.

OLIN HTH ALL PURPOSE ALGICIDE-30 EXTRA STRENGTH

is compatible with those chemicals normally used to treat pools and spas and is effective at both acid and alkaline pH. OLIN HTH ALL PURP ALGI-30 can be used in pools and spas treated with chlorine chemicals and may reduce the amount of those chemicals normally required. However, do not mix OLIN HTH ALL PURP ALGI-30 with concentrated dry or liquid chlorine products. OLIN HTH ALL PURPOSE ALGICIDE-30 EXTRA STRENGTH

STORAGE & DISPOSAL

STORAGE: Do not contaminate water, food, or feed by storage or disposal. Keep container closed when not in use. Leaking or damaged containers should be placed in a plastic bag and discarded in trash. Mop up spills with clear water. All pesticides should be kept out of reach of children and stored away from food.

DISPOSAL: Do not reuse empty container. Wrap container and place in trash.
