The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. A stamped copy is enclosed for your records.

1. Submit five copies of the finished labeling before you release the product for shipment bearing the amended labeling.
2. In the directions for use, change the "0.6 to 1.1 ounce of this product per 500 gallons of water" to half that dosage (e.g., 0.3 to 0.6 ounce per 500 gallons of water, or 0.6 to 1.1 ounce of product per 1000 gallons of water), as on your previous EPA-accepted label.

The new primary brand name "HTH® Non Foaming Algaecide 60" has been noted.

This product is used to control the growth of algae in swimming pools, exterior spas, whirlpools, hot tubs, decorative fountains and ponds that do not contain fish. For maximum effectiveness pools, spas, whirlpools, hot tubs, decorative fountains and ponds containing heavy growth of algae should be cleaned prior to using this product.

For pools having just visible algae growth add an initial dose of 11 to 17 ounces of this product per 10,000 gallons of water and remove settled algae debris by cleaning. Subsequent additions of 2 to 4 ounces of this product per 10,000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance.

For treatment of a freshly cleaned and filled pool add initially 6 to 11 fluid ounces of this product per 10,000 gallons of water.

Spas, whirlpools, hot tubs, decorative fountains and ponds having just visible algae growth require and initial dose 0.5 to 1 ounces of this product per 500 gallons of water. For treatment of a freshly cleaned and filled spa, whirlpool, hot tub, decorative fountain, or pond, add initially 0.6 to 1.1 ounce of this product per 500 gallons of water. Subsequent additions of 0.1 to 2 ounces of this product per 500 gallons of water should be made every 5 to 7 days after initial treatment for maintenance.

BEST AVAILABLE COPY

This product will prevent the growth of most algae during the off-season winter months when pools are not in use. For pools which have been properly treated during the swimming season and are free of visible algae, add 7 to 11 ounces of this product per 10,000 gallons of water. If at the end of the swimming season pools have some visible algae growth, add 13 to 19 ounces of this product per 10,000 gallons of water. It is necessary that a uniform distribution of this product be made throughout the water for maximum effectiveness. If pool is not covered, it may be necessary to repeat the treatment one or more times during the season.

This product is compatible with those chemicals normally used to treat pools and spas and is effective at both acid and alkaline pH. This product can be used in pools and spas treated with chlorine chemicals and may reduce the amount of those chemicals normally required. However, do not mix this product with concentrated dry or liquid chlorine products.
