GENERAL DIRECTIONS FOR FORMULATING:

CDB-63 is to be used only for repackaging or formulating as a disinfectant, sanitizer, fungicide, bactericide and algicide before the new product can be lawfully distributed in interstate commerce, registration by the Environmental Protection Agency is required.
