CDB-C3 is to be used only for repackaging or formulating as a disinfectant, sanitizer, fungicide, bactericide and algicide. Before the new product can be lawfully distributed in interstate commerce, registration by the Environmental Protection Agency is required.

**PHYSICAL AND CHEMICAL HAZARDS
STRONG OXIDIZING AGENT:**

Mix only with water. Use clean dry utensils. Do not add this product to any dispensing device containing remnants of any other product. Such use may cause a violent reaction leading to fire or explosion. Contamination with moisture, organic matter, or other chemicals may start a chemical reaction, with generation of heat, liberation of hazardous gases, and possible generation of fire or explosion. In case of contamination or decomposition, do not reseal container. If possible isolate container in open air or well ventilated area. Flood with large volumes of water, if necessary.

STORAGE AND DISPOSAL: Keep product dry in tightly closed container when not in use. Store in a cool, dry, well-ventilated area away from heat and open flame.
