On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act. Registration is in no way to be construed as an endorsement or recommendation of this product by the Agency. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others. Based on your response to the 1,2-Benzisothiazolin-3-one RED, the EPA has reregistered this product subject to the comments recorded in the succeeding paragraph. This action is taken under the authority of section 4(g) (2) of the Federal Insecticide, Fungicide and Rodenticide Acts, as amended. Reregistration under this section does not eliminate the need for continual reassessment of pesticides. The EPA may require submission of data at any time to maintain the registration of the subject product. 1. Make the following label changes: a. Revise the EPA Registration Number to read "1258-1251."

- b. As per the acute toxicity review, revise the "Hazards to Humans and Domestic Animals to read as follows:

"DANGER. Corrosive. Causes irreversible eye damage. Do not get in eyes, on skin, or on clothing. Harmful if swallowed. Harmful with absorbed through the skin. Harmful if inhaled. Avoid breathing dust. Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals.

Please note: the text, "Wear goggles or face shield and rubber gloves when handling", may remain in this section of the label.

- c. As per the acute toxicity review, add the following "First Aid" statement(s) to read as follows:

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Call a poison control center or doctor for further treatment advice."

The above statement should be placed after the, IF SWALLOWED:...., statement.

- d. As per the acute toxicity review and PR Notice 2001-1, add text, "In case of an emergency, for additional information call 1800-654-6911". The statement should appear after the statement, "Have the product container or label with you when calling a poison control center or doctor or going for treatment."

As per the acute toxicity review, the additional text below should be added to the "Note to Physician" statement that addresses the eye irritation concerns toxicity to read as follows:

- technical information on symptomatology;
- use of supportive treatments to maintain life functions;
- medicine that will counteract the specific physiological effects of the pesticide;
- company telephone number to specific medical personnel who can provide specialized medical advice.

- e. As per the acute toxicity review, add the following "User Safety Recommendations" section to read as follows:

User Safety Recommendations

User should wash hands before, eating, drinking, chewing gum, using tobacco, or use the toilet.

User should remove clothing/PPE immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing.

Users should remove PPE immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing.

- f. Add the following text to the "User Safety Requirements" text to read as follows:

"Follow manufacturer's instructions for cleaning /maintaining PPE. If no such instructions for washables exist, use detergent and hot water. Keep and wash PPE separately from other laundry."

"Discard clothing and other absorbent materials that have been drenched or heavily contaminated "with this product's concentrate. Do not reuse them."

- g. As per the Product Chemistry review, add the sub-heading, "Physical and Chemical Hazards" to appear directly below the "Environmental Hazards" statement.

- h. Under the Environmental Hazards statement, add the following statement to read as follows:

"Keep away from strong oxidizers."

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec.6(e). Your release for shipment of the product constitutes acceptance of these conditions.

Submit two (2) copies of the revised labeling bearing the labeling revisions listed above. A stamped copy of the label is enclosed for your records.

Triple rinse as follows: Empty remaining contents into application equipment or a mix tank. Fill the container 1/4 full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Triple rinse as follows: Empty remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container 1/4 full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times.
