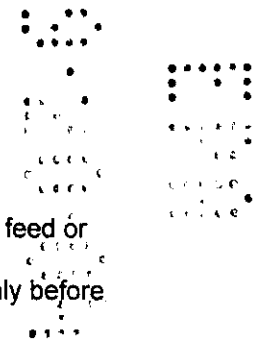

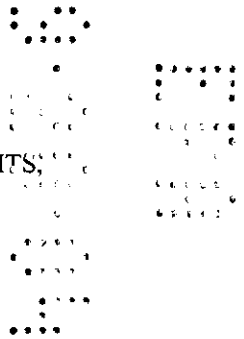

This notification is to make minor label changes resulting from the recent transfer of pesticide registrations from Number 72674 (Avecia) to Number 1258 (Arch Chemicals). The labels have been modified to include:

1. Removal of the warranty statement, which read:

breached within one year of sale. THE DURATION OF ANY IMPLIED WARRANTIES IS
LIMITED TO ONE YEAR.

limitations may not apply to you. IN NO EVENT SHALL AVECIA BE LIABLE FOR
ANY SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES, INCLUDING LOST PROFITS,
