Step 2: Sanitize

Step 3: Shock at least once a week.

Step 4: Add algaecide as directed.]

When used regularly this product will kill and control the growth of swimming pool algae. This product may be used in the same treatment program as most commonly used pool chemicals, but should not be mixed with any foreign material, including other water treatment chemicals. This product works best when added in several places to the pool with the pump or circulation system running. Wait 15 minutes before entering the pool or spa.
