Based on your response to the 1,2-Benzisothiazolin-3-one RED, the EPA has reregistered this product subject to the comments recorded in the succeeding paragraph. Reregistration under this section does not eliminate the need for continual reassessment of pesticides. The EPA may require submission of data at any time to maintain the registration of the subject product.

1. Make the following label changes:

a. Revise the EPA Registration Number to read "1258-1289."

b. As per the acute toxicity review, revise the "Hazards to Humans and Domestic Animals to read as follows:

"DANGER. Corrosive. Causes irreversible eye damage. Causes skin burns. Do not get in eyes, on skin or clothing. May be fatal if inhaled. Do not breathe vapor or spray mist. Harmful if swallowed or absorbed through the skin. Wear goggles or faceshield, coveralls over long-sleeved shirt and long pants, chemical-resistant footwear and socks, and chemical-resistant gloves made of waterproof material.

c. As per the acute toxicity review, the "First Aid" statements should be placed on the label in the following order:

IF IN EYES:....
IF INHALED:....
IF ON SKIN OR CLOTHING:...
IF SWALLOWED:...

- d. As per the acute toxicity review, the additional text below should be added to the "Note to Physician" statement that addresses the eye and skin irritation Tox. Category I and acute inhalation Tox. Category II to read as follows:
 - technical information on symptomatology;
 - use of supportive treatments to maintain life functions;
 - medicine that will counteract the specific physiological effects of the pesticide;
 - company telephone number to specific medical personnel who can provide specialized medical advice.
- e. Add the following text to the "User Safety Requirements" text to read as follows:

"Follow manufacturer's instructions for cleaning /maintaining PPE. If no such instructions for washables exist, use detergent and hot water. Keep and wash PPE separately from other laundry."

"Discard clothing and other absorbent materials that have been drenched or heavily contaminated with this product's concentrate. Do not reuse them." f. As per the acute toxicity review, add the following "User Safety Recommendations" section to read as follows:

User Safety Recommendations

User should wash hands before, eating, drinking, chewing gum, using tobacco, or use the toilet.

User should remove clothing/PPE immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. Users should remove PPE immediately after handling this product. As soon as possible, wash thoroughly and change into clean clothing."

- g. As per the Product Chemistry review, add the subheading, "Physical and Chemical Hazards" to appear directly below the subhead, "Environmental Hazards" section. labeling.
- h. Under the Physical and Chemical Hazards", add a statement regarding the incompatibility of the product with other chemicals (e.g., oxidizing agents) must be added to the product labeling.
- i. Place the "Storage and Disposal" statements in a text box for prominence.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec.6(e). Your release for shipment of the product constitutes acceptance of these conditions.

Submit two (2) copies of the revised labeling bearing the labeling revisions listed above. A stamped copy of the label is enclosed for your records.

No. 1258-1289 PESTICIDE DISPOSAL: [For containers > 5 gallons] Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal Law. If these wastes cannot be disposed of by use according to label instructions contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste representative at the nearest EPA Regional Office for guidance. Triple rinse as follows: Empty remaining contents into application equipment or a mix tank. Fill the container 1/4 full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times.

Latices: Natural and synthetic latices based on acrylate, butadiene, PVA, styrene and other monomers, for use in various applications, e.g., wax, paint, floor polishes, synthetic rubber latices, add 0.15 - 0.70% of this product (based on total weight of product).

Emulsion paints and Stains: for in-can preservation, add 0.15 - 0.70% of this product (based on total weight of product).

Oil-in-water emulsions: "Spin finish" solutions for use in the textile industry. Cutting/rolling oils. Soluble oils (metal and engineering industries), add 0.15 - 0.7% (based on total weight of product).

Adhesives: Carboxymethylcellulose (CMC) and derivatives, animal glues, adhesives based on gelatins and latex, add 0.15 - 0.7% of this product (based on total weight of product).

Paper coating compositions: Rosin dispersions. Starch and casein based products, Add 0.15-0.7% of this product (based on total weight of product).

Pesticide formulations: For product preservation. For ultimate use-dilution protection. This product is exempt from tolerance under 40CFR180,920, materials exempted from the requirements of a tolerance when used in accordance with good agricultural practice as inert (or occasionally active) ingredients in pesticide formulations applied to growing crops only. Based on the current 180,920 limit of 0.1% BIT in formulations, use levels of up to 1.4% (14,200 ppm) of this product are allowed, add 0.15 - 1.4% of this product (based on total weight of product).

Aqueous mineral slurries: add 0.1 - 0.50% of this product (based on total weight of product).

Tape joint compounds: add 0.15 - 0.70% of this product (based on total weight of product).

Inks and dyes: Water-based inks, ink concentrates, and fountain solutions, add 0.15 - 0.7% of this product (based on total weight of product).

Pigment Dispersions: Pigment dispersions and pigment cakes, add 0.15 - 0.70% of this product (based on total weight of product).

Photographic Emulsions: To preserve the integrity of photographic emulsions and photo processing rinse solutions, add 0.01 - 1.0% of this product (based on total weight of product).

Specialty products and household products: Laundry additives, liquid laundry detergents, fabric softeners, stain removers, home cleaning products, floor cleaners, floor waxes and polishes, surface cleaners, window cleaners, dish detergents, car care products, add 0.15 - 0.45% of this product (based on total weight of product).

Preservation of Fresh Animal Hides and Skins. To preserve the integrity of fresh animal hides and skins prior to or during processing, use 37 fluid ounces to 5 gallons (2.4-43.3 lbs) of this product per 1000 pounds of hides or skins. Add the appropriate quantity of this product to the brine solution during the curing operation or treat hides or skins with an appropriately diluted aqueous solution during other portions of the processing operation. The specific use rate and contact time needed to control microbial attack will depend upon the degree of decomposition of the hides or skins prior to treatment. Leather Processing Solutions. Use this product at levels of 0.07 – 0.57% for the preservation of leather processing solutions.

General Recommendations: The concentration required to give protection depends on several factors. These include susceptibility of the system to microbiological degradation, the extent to which microorganism can gain access, the species involved, pH, temperature, and length of time for which protection is required. For protection against bacterial attack, a concentration within the range of 0.05 - 1.0% of this product is almost invariably sufficient.

The control of mold growth, particularly on paste products of high solids content, may occasionally demand dosages above 0.7%.

In dilute fluid systems, spoilage is usually controlled with dosages not greater than 0.25%.
