FIRST AID

Holding material over toilet bowl, pour 2 to 4 ounces of undiluted liquid into toilet bowl. Clean thoroughly, especially under rim and at water outlets. Rinse seat and cover with fresh water, then flush toilet. Rinse out mop.

TO CLEAN, DEODORIZE AND DISINFECT URINALS

Remove screen or metal strainer from urinal. Hold bottle over urinal and saturate bowl mop with material. Clean urinal thoroughly, covering entire inner surface, especially the grooves along the sides and the water outlets at the top. Pour 2 to 5 ounces of material around the edge and through the drain pipe. Allow to stand several minutes and scrub inside of pipe thoroughly.
