GENERAL INFORMATION

ZEP FORMULA 777 Weed Killer is a water-emulsifiable concentrate to be diluted with water and applied as a spray on non-cropland areas where bare ground is de-sired. It is an effective general herbicide for the control of many annual and perennial weeds and is particularly useful for the control of perennial grasses.

TIMING

To control most weeds for an extended period of time on non-cropland areas such as railroad, highway, and pipeline rights-of-way, petroleum tank tarms, lumber-yards, storage areas, and industrial plant sites, for best results, apply ZEP FORM-ULA 777 in use solution when weeds are less than six inches high. Do not apply when ground is frozen.

DIRECTIONS

For annual weeds and grasses such as foxtail, ryegrass, wild oats, crabgrass, and rogweed, mix one part ZEP FORMULA 777 with nine parts water and apply with a sprayer at the rate of one gallon per 100 square feet.

For perennial weeds and grasses such as bluegrass, redtop, purpletop, aster, dandelion, and goldenrod, mix one part ZEP FORMULA 777 with four parts water and apply with a sprayer at the rate of one gallon per 100 square feet.

For Johnson grass and other hard-to-kill perennial weeds and grasses such as Bermuda grass, Dallis grass, nutgrass, saltgrass, and horsetail, mix one part ZEP FORMULA 777 with two parts water and apply with a sprayer at the rate of one gallon per 100 square feet.

Dilutions of ZEP FORMULA 777 with water form an emulsion. It should be stirred thoroughly before use. If the emulsion stands for any length of time before use. it should be restirred.

For faster kill of established weeds and grasses, dilute ZEP FORMULA 777 with kerosene, mineral spirits, or fuel oil in the same quantities as called for above for water.

CAUTION

- KEEP OUT OF REACH OF CHILDREN -

Harmful it swallowed. May irritate eyes, nose, throat, and skin. Avoid breathing of spray mist, in case of contact, flush skin or eyes with plenty of water; for eyes, get medical attention.

IMPORTANT!

DO NOT apply, drain, or flush equipment on or near desirable trees or other plants or on areas where their roots may extend, or in locations where the chemical may be washed or moved into contact with their roots, DO NOT use on lawns, walks, driveways, tennis courts, or similar areas. Prevent drift of spray to desirable plants, DO NOT contaminate damestic waters. Keep from contact with fertilizers, insecticides, fungicides, and seeds, Thoroughly clean all traces of ZEP FORMULA 777 from application aquipment immediately after use; otherwise, injury to de-sirable vegetation may result when equipment is used again. DO NOT re-use container; destroy when empty,
