TIMING

To control most weeds for an extended period of time on non-croptand areas such as refired, highway, and pipeling rights of way, petroleum tank tarms, lumbers yarday starage areas, and industrial plant sites, for best results, apply ZEP FORM-ULA 777 in use solution when weeds are less than six inches high. Do not apply when ground is frozen.

DIRECTIONS

For annual WEEDS and grasses such as <u>faxtall</u>, ryegrass, wild-oats, crabgrass, and cagward, mix one part ZEP FORMULA 777 with nine parts water and apply with a sprayer at the rate of one gallon per 100 square feet.

For perennial-weedewand-grasses such as bluegrass, sector, purpletop, aster, dandsilon, and geldenred, mix one part ZEP FORMULA 777 with four parts water and apply with a sprayer at the rate of one gallon per 100 square feet.

For Johnson-geass and other hard-to-kill pertinitian weeds and grasses such as Berminder grass, Dallise grass, nutgrass, saltgrass, and horsetail, mix one part ZEP FORMULA 777 with two parts water and apply with a sprayer at the rate of one gallon per 100 square feet.
