Dear Mr. Beach:

The following amendment, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable subject to the conditions listed below.

- Update as per PR Notice 2001-1

Conditions

Revise the label as follows:

1. Revise the "Ingredients Statement" to include the phrase "Total.....100%"
2. Delete the term "dangerous" and revise to state: "Kills Many Germs" as dangerous is currently not an accepted claim for antimicrobial products.
3. Abbreviated names of public health organisms are not acceptable. Revise the center panel to list the genus and species: "Staphylococcus aureus," "Salmonella choleraesuis," and "Pseudomonas aeruginosa." In addition, place an asterisk after "Herpes Simplex Type 2*"

4. Revise the first section on the left column to list only hard non-porous surfaces by indicating: "glazed tile."

5. You claim that this product is a cleaner and deodorizer. As such you must have directions for these uses. Revise the section beginning: "Shake can well before using. Hold can..." to begin: "**For Cleaning and Deodorizing:** Shake can well before using. Hold can..."

6. Revise the statement beginning: "after use equipment and utensils in the area..." to read "after use *surfaces* in the area..."

7. Add the following statement to the "Directions for Use" section of the label: "*Do not use to clean or disinfect glasses, cookware, or eating utensils.*"

8. Revise the Disinfection directions by stating: "...cover it with white foam, and allow a *contact* time of 10 minutes..." This will bring you label into agreement with today's standards for label language. Also change the heading of this section to read "**For Disinfection and Virucidal Activity**"

9. Revise the "Storage and Disposal" section as follows:

A. Place the statement: "Do not Puncture or Incinerate" in the Container Disposal section of the label.

B. Revise the Pesticide Storage statement to read: "Utilize locked storage which is not near heat or open flame."

C. Bold the **Pesticide Disposal** heading.

10. Your Precautionary language is not in agreement with the label review manual and as such revise the "Precautionary Statements" to read exactly as follows:

"Cause moderate eye irritation. Avoid contact with eyes or clothing. Wash thoroughly with soap and water after handling."

11. As per PR Notice 2001-1, the First Aid statements are to be ordered from most toxic to least toxic route of exposure. Thus revise such that "If in Eyes" is followed by "If on skin or clothing" then "If swallowed" and finally "If Inhaled."

12. The sites listed on your label are classified as commercial and institutional sites. Your label does not include industrial sites. As such, revise your label in two instances near the bottom of the right panel to state: "For *Commercial* and Institutional Use Only" and "This product is designed exclusively for *commercial* and institutional use by trained..."

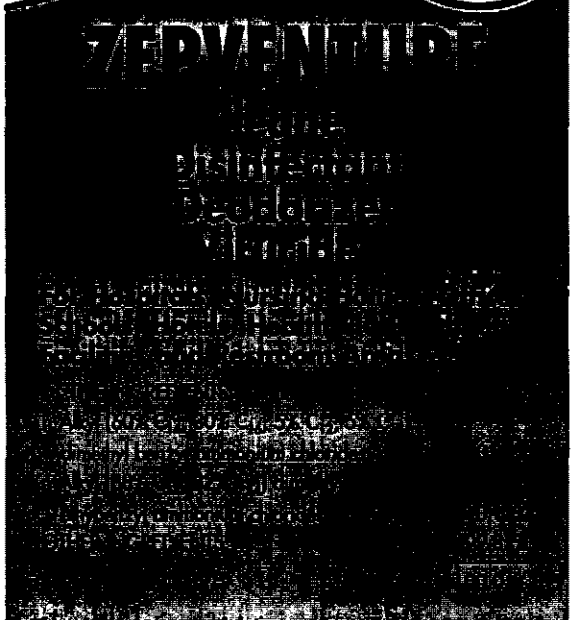

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. This product is not for use on medical devices and equipment. Shake can well before using. Hold can 6 to 8 inches from surface to be cleaned. Spray area, covering it with white foam. Wipe off with clean cloth or sponge. For hard to clean surfaces, allow foam to soak and penetrate, and then wipe off. Before using, food products and packaging materials must be removed from the room or carefully protected; after use, equipment and utensils in the area must be scrubbed with a detergent and rinsed with potable water.

FOR DISINFECTION: Remove gross filth or heavy soil. Spray the area to be treated, covering it with white foam, and allow a wet-contact time of 10 minutes before wiping off or, for food contact surfaces, using a detergent wash and potable water rinse.

STORAGE & DISPOSAL

DO NOT CONTAMINATE WATER, FOOD, OR FEED BY STORAGE AND DISPOSAL. Do Not Puncture or Incinerate!
Pesticide Storage: Do not store near heat or open flame.
Pesticide Disposal: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.
