CAUTION

May be harmful if swallowed, inhaled, or absorbed through skin. Avoid breathing spray mist and provide adequate ventilation of area being treated. Do not smoke while using. Contact with skin, eyes, or clothing should also be avoided. Wash thoroughly with soap and warm water after handling. Avoid contamination of food, utensils and food preparation areas. Do not use in commercial food preparation areas or for edible products areas of food processing plants. Remove pets from area before spraying.

Statement of Practical Treatment

If Swallowed: DO NOT INDUCE VOMITING. Contact a physician or Poison Control Center immediately for treatment.

If on Skin: Wash all areas contacted by product with soap and water. If irritation persists, contact a physician.

If in Eyes: Flush eyes with plenty of water. If irritation persists, contact a physician.

ENVIRONMENTAL HAZARDS

Do not spray near water, fish, birds, bees, honey bees, or animals.

**STORAGE AND
DISPOSAL**

**READ DIRECTIONS
CAREFULLY**

Point spray nozzle toward insect's nest, hole or crevice where infestation is known to exist. Spray area until saturated with material. Also spray around in the general area until it is completely wet. This treated area will have a residual killing action and prevent reinfestation for 2 to 4 weeks. If the residual film becomes ineffective on account of rain or other causes, repeat treatment.

Always spray with the wind at the user's back.

DIELECTRIC

Cup Test: Electrodes 1/10" apart, no breakdown up to 25,000 volts.

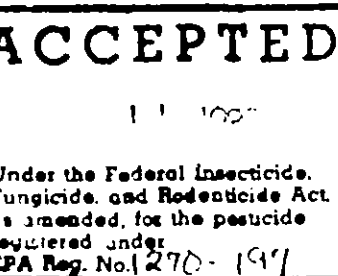
