CAUTION

DIRECTIONS FOR USE (Cont'd)

gallons or more may be resealed and offered for reconditioning.

General: Consult Federal, State or Local Disposal Authorities for approved procedures.

For Use In: Food processing plants and storage areas, restaurants, office buildings, motels, hotels, sports arenas and stadiums, and warehouses.

Avoid contamination of feed and food stuffs. Foods should be removed or covered during treatment. All food processing surfaces should be covered during treatment or thoroughly cleaned before using. When using the product in these areas, apply only when the facility is not in operation.

This product is formulated for use, undiluted, in mechanical sprayers which are designed to produce particles of aerosol size.

Space Spray - Undiluted - to kill flies, mosquitoes, gnats, and exposed cockroaches: Cover or remove exposed food and food handling surfaces. Close room and shut off all air conditioning or ventilating equipment. Apply at the rate of 0.3 fl. oz. of undiluted concentrate per 1000 cu. ft. of space. Position aerosol generator in the center of room, directed towards upper corners and ceiling, or move about the room to achieve a uniform distribution. Leave room closed for one hour. Ventilate room thoroughly before re-entry. Repeat as necessary.

Contact Spray - undiluted - to kill Cockroaches, Ants, Earwigs, Spiders, Grain Insects (Adults of Confused Flour Beetles, Sawtooth Grain Beetles, Shiny Spider Beetles), Grain Mites, Sowbugs, and Centipedes in Accessible, Sheltered Situations: Avoid contamination of stored food and food stuffs by removing before spraying. With the equipment described above, adjusted to give a coarse, wetting spray, apply the product into all cracks and crevices in woodwork, walls, floors, underneath sinks, behind pipes, around window and door frames, under surfaces of shelves, drawers and work tables, behind and beneath cabinets, refrigerators, and stoves, in and around waste containers, switch panels, junction boxes and floor drains. Contact as many insects as possible. Use at a dosage rate of approximately 0.3 fl. ozs. per 1000 cu. ft. of room space. Repeat applications as necessary.
