

**PRECAUTIONARY STATEMENTS  
HAZARDS TO HUMANS AND  
DOMESTIC ANIMALS  
CAUTION**

May be harmful if swallowed. Inhaled or absorbed through skin. Avoid breathing spray mist and provide adequate ventilation of area being treated. Avoid contact with skin, eyes and clothing. In case of contact immediately flush skin and eyes with plenty of water. Wash thoroughly with soap and water after handling. If poisoning occurs, get prompt medical aid.

**STATEMENT OF PRACTICAL  
TREATMENT**

**If Swallowed:** Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Do not give anything by mouth to an unconscious person. Get medical attention.

**If on Skin:** In case of contact, remove contaminated clothing and immediately wash skin with plenty of soap and water.

**If in Eyes:** Flush eyes with plenty of water. If irritation persists, contact a physician. **NOTE TO PHYSICIAN:** Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine by injection is antidote of choice.

Do not use in food areas of food processing plants, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed. In living areas, all food processing surfaces and utensils should be covered during treatment or thoroughly washed before use. Cover exposed food. Remove cats and birds and cover fish aquariums before spraying. Do not allow children or pets to contact treated surface until spray has dried.

**PHYSICAL OR CHEMICAL HAZARDS**

Do not use or store near heat or open flame.

**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**STORAGE AND DISPOSAL**

Store in a cool, dry area away from heat or open flame. Do not contaminate water, food, or feed by storage and disposal. Open dumping is prohibited. Pesticide spray mixture, or residue that cannot be used according to label instructions, must be disposed of according to Federal, state or local procedures under the Resource Conservation and Recovery Act. Do not reuse empty container. Triplicate and forward and offer for recycling, recycling, or disposal in an approved sanitary landfill or for other plastic containers disposal by incineration or other method approved by State and local authorities.

**DIRECTIONS (Cont'd)  
SHAKE WELL BEFORE USE.**

For use in Apartments, Condominiums and Similar Living Areas and in Nonfood Areas of Kitchens and Commercial Buildings, such as, Warehouses, Theaters, Office Buildings, Schools, Motels, Hotels, Restaurants and Food Processing Facilities.

**General Use:** Use product as a spot treatment to control cockroaches, water bugs, silverfish, ticks, fleas, and other insects listed below. Apply this product as a coarse spray to localized areas where pests are found or an infestation may occur. Spray surfaces until wet. Repeat as needed.

**To Kill Cockroaches, Ants, Crickets, Silverfish, Spiders and Sowbugs:** Spray areas where these pests are found or may hide, including dark corners of rooms and closets, cracks and crevices in walls, along baseboards and door and window frames, behind and beneath sinks, stoves, refrigerators and cabinets and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. For ants, apply to ant trails, also around doors and windows and wherever else these pests may find entrance. Repeat as necessary.

**To Kill Brown Dog Ticks and Fleas:** Thoroughly apply as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor and floor coverings where these pests may be present. Old bedding should be removed and replaced with clean, fresh bedding after treatment of pet area. DO NOT spray pets with this product. Treat pets with a product registered for animal application to control the source of the flea infestation.

**Flies and Mosquitoes:** Use only out of doors as an aid in reducing annoyance from these insects. Spray outside surfaces of window and door frames, as well as, other areas where these pests may enter. Also spray dark corners and localized resting areas such as under eaves or porches, patios and garages where these insects may congregate. Flies and mosquitoes coming to rest on treated surfaces will be killed. Repeat treatment when necessary.
