

- Qualify porcelain surfaces as glazed porcelain surfaces.
- 2. Revise the Precautionary Statements as follows: Corrosive. Causes irreversible eye damage and skin burns. Maybe harmful if absorbed through skin or swallowed. Do not get in eyes, on skin or in clothing. Wear goggles or face shield and rubber gloves and protective clothing when handling. Wash throughly with soap and water after handling. Remove contaminated clothing and wash clothing before reuse.
- Reorder your First Aid Statements as follows: IF IN EYES, IF ON SKIN OR CLOTHING, IF SWALLOWED followed by IF INHALED.
