To insure that all bacterial and viral agents are killed as stated, use 5 oz of product concentrate per gallon of

General Cleaning: Using the appropriate cleaning solution for the type of surface to be treated, thoroughly clean the surface, allow to air dry. If needed use additional solution. Replace solution daily.
